# Ward Councillor Report: April-May 2023

#### **Master's House Landscaping**

A Herefordshire-based contractor, Owen Pell, has been appointed to undertake the landscaping work at The Master's House. The work is planned to be completed in time for the main summer visitor season in August.

The Town Council has been asked for its input regarding potential future use of this public space. This request is to assist with the development and drafting of an appropriate range of licensing agreements. If councillors have any queries or issues regarding this request, can these be directed in the first instance to me as the ward member.

#### **Viaduct Housing Development**

Work has been commenced on site by the developer, Bloor Homes, without the necessary permissions having been granted or necessary planning conditions met. Police have visited the site with respect to concerns from a local resident regarding nesting birds ... the site is a known nesting location for skylarks which lay their eggs on the ground, as well as a range of other protected wildlife species. I am advised by Planning Officers that enforcement action is underway and Enforcement Officers are proceeding with advice and support from Ecology Officers.

Detailed Planning Permission is yet to be granted for the first phase of this controversial development and conditions applied at outline permission stage by the Secretary of State have not all been discharged. It is very disappointing that such an experienced developer is playing fast and loose with the planning system rather than following the rules in a responsible manner. This does not bode well for the future and I would encourage all involved at Bloor to start treating this development and our community with consideration and respect. Everyone is watching.

#### McCarthy & Stone Development of 'Masefield's Meadow'

The Ledbury Neighbourhood Development Plan has been approved at referendum on 4 May with a 'Yes' vote of 82.7%. One of the consequences of this is that the protection of this green space in planning policy terms has been reacquired.

The planning application (P223248) for a development of Retirement Living apartments with associated access, car parking, landscaping, ancillary facilities, and associated works remains under consideration at the outline stage. As a consequence of the redesignation of the land as protected green space I have notified the case officer that I will be requesting that the application be referred to committee should the application be recommended for approval.

### **Frith Wood Access**

I have received a number of emails from concerned residents following the installation of signage at the entrance to Frith Wood House stating there was no right of way, which appeared to originate from Herefordshire Council. The signage was nothing to do with the Council and the householder has been instructed to remove it with immediate effect.

Advice from Forestry England remains that the public should feel able to continue use their licence access along the forest road, unless and until legal agreement is arrived at to the contrary.

### **Parking Problems and Traffic Regulation Orders**

I am very disappointed that the Town Council is seeking to disrupt the development of highway engineering solutions to parking problems experienced by residents and businesses in certain areas of the town without justification or local support. In my ward, parking problems for residents of Masefield Avenue, Belle Orchard and Belle Orchard Close and Queen's Court have been in evidence for years. As ward member I have been

working since at least 2014 to get the priority of these engineering works bumped up the list in the Public Realm Annual Plan.

It is deeply frustrating to have parish councillors actively working against ward members on this matter, just as soon as the parish is given the opportunity to influence how county council money is spent on TROs – something hard won by the Indy-led council administration. This is especially annoying when councillors are fully aware that highway consultants have been contracted to undertake options analysis and funding already committed to draft improvement schemes.

The Town Council's Standing Orders require that Ward Members are copied in on correspondence with the County Council. This persistently does not happen, and has not happened in this instance either. Please can all ward members be copied in on such correspondence with immediate effect and please may I be copied in on past correspondence on this matter.

As ward member I shall be requesting that the draft designs are completed as contracted, and that these are then provided to the Town Council for comment and consideration. It is at the point where you actually have something concrete in front of you to consider that it is appropriate to decide whether or not to support it, and not before.

### **Household Support**

Grants, advice and assistance continue to be available for households facing hardship. 100% discount on Council Tax continues for qualifying households and £1.7m has been allocated to continue support in a variety of ways during 2023.
