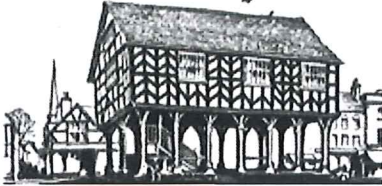

Ward Councillor Report: April - May 2022

Master's House

The project is progressing as outlined in my previous report. Additional funding has been secured to undertake the main landscaping of the square area and architectural/engineering plans have been commissioned to revise the approved design to reflect issues with interfacing to retained areas of paving, water management and to reduce the slope of the square to improve its utility for public events and markets.

Core Strategy Update

The detailed spatial options for city, market towns and rural areas are about to be consulted upon. The Ledbury Place Shaping consultation takes place on **20 June at 18:30** and I suggest it would be worthwhile having a workshop session with councillors in advance of that consultation in order to discuss the documentation..

Public Realm Annual Plan 2022-23 and Maintenance Fund

I remain hopeful that the information provided in my last report remains current as regards the agreed programme of works for 2022-23 in the Ledbury area for the BBLP Annual Plan. There has been some confusion regarding which works should be considered as priorities recommended to the Extraordinary Maintenance Fund and I have made some suggestions on this which are covered elsewhere in the council's June agenda.

Business Summit and Investment Plans inc Levelling Up bids

The latest economic summit with businesses local to Ledbury will be held in The Feather's Hotel on the evening of **21 June**. Opportunities to progress delivery of the Ledbury elements of the Market Towns Investment Plans are being explored, including what might be appropriate to propose for the Herefordshire North Constituency's MP-supported projects for Levelling-Up funding. The county's Levelling-Up bids need to be submitted to Dept of Levelling Up, Housing and Communities by early July. Two bid will concentrate on projects in each of the county's two constituencies, with the support of their respective MPs, the third bid will be centred on projects in Hereford City.
