#### E.18-07.15 MINUTES

The Minutes of the meeting held on 28<sup>th</sup> May 2015, copies having been previously circulated, were confirmed as an accurate record and signed by the Chairman.

Members were advised that no quotations for tree works to open up the vista from the 'cricket pitch' had been received in time for the meeting, but that one of the tree surgeons invited to quote for the works had requested a site visit to ascertain the work involved.

# E.20-07.15 RECREATION GROUND

The Clerk advised that Fields in Trust had confirmed that they would be happy to protect the Recreation Ground under the Centenary Fields programme and that as part of the process, the Council would be required to register the land at the Land Registry and obtain an up to date valuation of the land.

Members considered for approval, the draft deed between Ledbury Town Council and National Playing Fields Association, copies having been circulated.
