E.23-03.16 APOLOGIES

E.24-03.16 DECLARATIONS OF INTERESTS

E.25-03.16 PUBLIC PARTICIPATION

There were no members of the public present.

E.26-03.16 MINUTES

The Minutes of the meeting held on 11th February 2016, copies having been previously circulated, were confirmed as an accurate record and signed by the Chairman.

E.27-03.16 TOWN CENTRE

Members considered applying to Herefordshire Council for pre-application planning advice for restoration works to the War Memorial, at a fee of £150.

Recommendation to Full Council: To apply for pre-application planning advice.

E.28-03.16 CEMETERY

1. Members considered a request from a resident of Oakland Drive that the Council install fencing on the north eastern boundary of properties backing on to the cemetery extension along the line of an existing boundary hedge. Members were shown photographs of the area and given costs for fencing.

Recommendation to Full Council: That fencing is not installed in this area.

2. Gravedigging and grave preparation

Members considered allowing funeral directors to use their own grave diggers for interments, subject to them being pre-approved by the Town Council; booking and payments would then become the responsibility of the funeral director. All gravediggers would be required to abide by prescribed health and safety standards and a code of working practice.

Recommendation to Full Council: That principle. **Funeral** in

Directors be allowed to use their own gravediggers, but, that the matter be referred to Cemetery Working Party to

consider in further detail.

E.29-03.16 THE PYTEL SCULPTURE

The Clerk advised that the Helping Hand Company had generously offered to meet the cost of between £500 and £2,500 for a technical survey in order to gain approval from the Highway Authority for the structure to be erected in the Public Highway.
