C.140 - 11.17 APOLOGIES

Apologies were received from Cllrs D Baker, J Roberts and A Harrison.

C.141 - 11.17 DECLARATIONS OF INTEREST

Councillor Hopkins declared a non-pecuniary interest at Item 6. Committee Membership.

The Clerk confirmed that staff were not required to declare interests but that she would be leaving the meeting at item 13.1.

A member of the public was pleased that the Town Council website was going to be 'revitalised'. Referring to recent statements in the press, the member of the public suggested that it would be simpler if Cllr Harrison were to be allowed to take part in committees.

C.145 - 11.17 OPERATIONAL REVIEW

Councillor Barnes reported that the main action that resulted from the meeting which took place on 25 September 2017 was that the Council should investigate writing a strategic action plan. Mr Goodison of LGRC Associates had offered to forward some examples.

Councillor Barnes proposed the setting up of a working party to take forward an action plan. Councillor Shields proposed an amendment, setting up a working party to cover **all** recommendations from the Operational Review. The Clerk highlighted that if this proposal was adopted it would mean that the recommendations made by the Standing Committee, especially in relation to the Deputy Clerk, would be put on hold.

Councillor Crowe highlighted that staffing in the Office could not continue as it was. The job description for the Deputy Clerk had been considered by the Standing Committee in detail, having reviewed other areas and taken into account input from the Clerk who knew what was required from the position.

A lengthy discussion took place. Councillor Eager highlighted the need for an appropriate person to cover when the Clerk was absent; the Operational Review had prioritised the need for a Deputy Clerk.

A vote taken on the proposed amendment was LOST by 5 votes to 8 with one abstention.

A second amendment was proposed to include the wording, 'with the exception of the employment item on this agenda'.

A vote took place, For 12, Against 2

RESOLVED: That a Working Party be

established to write an action plan, regarding moving forward on all of the recommendations of the Operational Review, with the exception of the employment

item on this agenda.

VOTING: For 13 Against 1
