### Minutes of Annual Meeting held on 25 June 2020 via ZOOM

#### C.31 TO ELECT THE TOWN MAYOR FOR 2019/2020

Councillor Howells, as the outgoing Chairman, asked for nominations to the role of Town Mayor of Ledbury Town Council for the 2020/21 municipal yer.

Councillor Eakin proposed Councillor Daniel Vesma as Town Mayor for the 2020/21 Municipal year, which was seconded by Councillor Knight.

As there were no other nominations a vote was held and it was:

RESOLVED that Councillor Daniel Vesma be duly elected to the position of Town Mayor, by a unanimous vote, following which Councillor Vesma signed his Declaration of Acceptance of Office to the role of Town Mayor.

Councillor Phillip Howells invested the new Town Mayor and relinquished the position of Chairman.

In his opening speech Councillor Vesma thanked his fellow Councillors for the unanimous vote. He noted the work that Councillor Howells had carried out throughout the 2019/20 municipal year including the Corporate Plan and Civic duties. Councillor Vesma went on to note that his plans for the council were somewhat modest due to the Covid-19 pandemic and stated that his plans were to strengthen the council's policies to ensure forward thinking and deliver the best for Ledbury's residents.

He advised that teamwork was an essential quality for the council and that he was looking forward to potentially welcoming new colleagues to Ledbury Council.

# C.32 a. Vote of thanks for 2020/2021 mayor and presentation of past mayors Insignia

Councillor Vesma made a personal statement expressing his thanks to the past mayor. Councillor Phillip Howells, especially in the last year.

### b. Retiring Mayors response and closing remarks

Councillor Howells updated members on the mayoral events that he attended throughout the year Town Mayor. He advised that he attended 70 events including some outside of Herefordshire to show that the Council are interested in supporting and cooperating widely on joint interests and not just in the Councils parochial concerns.

The latest Mayoral activities included helping Ledbury Traders Association celebrating being able to open again on 15 June with a Town Crier and calling at many of the shops to 'declare them open' and he advised that he had formally signed the Armed Forces Covenant for Ledbury at a virtual signing event earlier in the day.
