Appeal by Bloor Homes Western relating to the application to Herefordshire Council for a mixed use levelopment including the erection of up to 625 new homes (including affordable housing), up to 2.9 hectares of B1 employment land, a canal corridor, public open space (including a linear park), access, drainage and ground modelling works and other associated works The proposal is for outline planning permission with all matters reserved for future consideration with the exception of access.
