3. Local Government Transparency Code 2015 (document):

Perused and discussed, agreement (amended) that this should be adopted as a framework document for LTC.

Re Part 3 Local Authority Land to include Centenary Fields Recreation Ground, Closed Churchyard, Cemetery, Dog Hill and various amenity areas in Deerpark, also properties such as Town Council Offices and The Market House.

4. Invitation to Tender (Website) Document:

Members discussed in depth and at length the draft document produced by Cllrs Hopkins & Shields, members in particular went through the introduction & mission statement, the committee roles and working, councillors presence, roles & councillor/staff contactibility. There were many and varied suggestions for changes and amendments which were taken on board by Cllrs Hopkins & Shields and will be presented in version 2 of the draft invitation to tender document, and looked at again at the next WP meeting.

Members requested written articles for Dog Hill (history) & new Town Crier. Inclusion of Full Council meetings (purpose), working parties and outside bodies. Changes in images including putting Market House and Church Lane as dominant photos on welcome page.

- f. Cllr Barnes to supply Cllr Hopkins with a comprehensive committee function list.
