	i) LSCA Stage 1 = assess capacity for a) residential on land around settlement, and b) 12ha employment west of town. Aim is to establish settlement boundary and for NDP to be made asap. If time / budget allow, identify 'Exceptional Key Views' for NDP Key Views policy (see 5. below). Also input into GI strategy.	
	ii) LSCA Stage 2 = assess capacity for other landuses and produce future ('Ledbury 2050'?) zoning plan.	
	iii) Both will start at same time, but Stage 2 will extend into 2021 / beyond.	
	iv) Total fee budget for LSCA is £10k. This should cover all of LSCA Stage 1 and the baseline information-gathering for Stage 2. Separate funding can be sought for Stage 2.	
	v) Given timescale, seems unlikely that volunteers will cover as much as hoped esp. gathering & digitising baseline / analysis so CT / CL to do.
