#### P691. APOLOGIES FOR ABSENCE

Apologies were received from Councillors Bradford, Harvey and Manns.

# P692. DECLARATIONS OF INTEREST AND WRITTEN REQUESTS FOR DISPENSATIONS

Councillor Sims advised of a declaration of interest in respect of the request for signage in Ledbury due to him being a business owner in the town. He informed members that he would take part in the discussion of this item but would not vote on it.

#### P693. PUBLIC PARTICIPATION

No members of the public were present.

# P694. TO APPROVE AND SIGN THE MINUTES OF THE ECONOMY & PLANNING COMMITTEE MEETING HELD ON 10 NOVEMBER 2022

Councillor Hughes highlighted two typing errors on pages 4251 & 4252 within the minutes. He also requested that the 2<sup>nd</sup> resolution be amended on minute no. P687a to read 'That the Clerk will send out the **link** to the Neighbourhood Planning Newsletter to the Planning Committee members electronically in the future'.

#### **RESOLVED:**

That the minutes of the Economy & Planning Committee be signed as a correct record, subject to the above amendments being made.

#### P695. TO REVIEW THE ACTION SHEET

P680(1) – That the Clerk prepare a press release asking members of the public to provide suggestions of sites where dropped kerbs could be installed around the town.

Councillor Morris queried whether this press release was on the Ledbury Town Council website. The Clerk advised that she would check and informed members that she received notification from Herefordshire Council advising that Ledbury would not be receiving any dropped kerbs in town in this year's budget.

P685(1) – That the Clerk will ask Herefordshire Council if the bus stop outside the Alms Houses can have a "green" roof.

Councillor Morris asked for the status of this action point to be changed to 'ongoing'.

P685(2) – That once a start date has been agreed in respect of the works to the War Memorial the Clerk arrange a meeting with Herefordshire Council Officers to discuss how this work could be co-ordinated with the works on the bus stop outside the Alms Houses.

Councillor Morris asked for the status of this action point to be changed to 'ongoing'.

Members asked the Clerk whether there was a start date for the War Memorial works, she informed them that there is no fixed date now, but it is likely to commence early Summer 2023.

P687a(2) – That the Clerk will send out the Neighbourhood Planning Newsletter to Planning Committee members electronically in the future.

Councillor Hughes asked if this could be amended as per the minutes to read 'That the Clerk will send out the link to the Neighbourhood Planning Newsletter to the Planning Committee members electronically in the future'.

P688b(2) – That the Clerk write a letter to West Midlands Rail Executive (WMRE) in support of the plans to improve disabled access at Ledbury Train Station.

Councillor Morris asked the Clerk if she had received a response to this letter. The Clerk informed members that she had not received a response but that was expected due to it being a letter of support.

# P696. PROPSAL RECEIVED FROM EAT, SLEEP, LIVE HEREFORDSHIRE

Members were disappointed in the lack of information received form Eat, Sleep, Live Herefordshire. Councillor Sims informed members that he believed this Tourism Campaign is not the right choice for Ledbury Town Council as a more bespoke plan is required. Members discussed whether a marketing consultant



could be approached to help promote Tourism in Ledbury. Members also discussed that once the information from the Herefordshire BID has been received this will help to get an idea on areas to improve in marketing the town as the BID will have access to resources and information that the Town Council will not. He proposed that the proposal from Eat, Sleep, Live, Hereford not be accepted, but that the Council continue to work with and promote Visit Hereford. The outcome of the proposal was 5 for and 1 against.

Councillor Shields proposed that a Task & Finish group be set up to discuss this matter further. Councillor Sims agreed to chair this Task & Finish group to discuss and brainstorm ideas to boost marketing in the town. Members suggested that all local businesses should be invited to attend this Task & Finish group, all members were in favour.

Councillor Sims proposed that in the meantime Ledbury Town Council will carry on promoting the town as normal and use the Visit Herefordshire website as it is a free platform. All members were in favour apart from one.

#### **RESOLVED:**



Members discussed the lack of signage in Ledbury as a big tourism issue as tourists are not aware of the many side streets and lanes off the main High Street. Councillor Sims highlighted that this would benefit all businesses in Ledbury, and it would be as simple as signs reading 'more shops this way'. The Town Clerk advised members that she had raised this item during a recent meeting with Economy & Place officers at Herefordshire Council, and it may be possible to fund new signs from the upcoming Shared Prosperity Fund.

#### **RESOLVED:**

That the Clerk investigate the cost and possibility of having more signage put in place around the town to identify areas other than The Homend and High Street where there are other shops and businesses that may be of interest to tourists.

#### **Ledbury Market Town Investment Plan**

Following extensive local engagement, the market town economic development investment plans (MTIPs) for Ledbury was adopted. The plan identifies potential projects in each, and funding opportunities for them.

#### **Funding Opportunities**

- UK Shared Prosperity Fund UK Government approves local spending plans for UK Shared Prosperity Fund (UKSPF). Funding will turbo-charge levelling up: supporting local businesses, boosting skills, reviving high streets and improving local pride. HC will identify spend for the first year which will end on 31 March 2022.
- Levelling Up Fund. Landscaping of the Master's House is one of the key Levelling Up projects in Herefordshire.
- Rural England Prosperity Funds a top-up to the UKSPF and is available to eligible local authorities in England. It succeeds EU funding from LEADER and the Growth Programme which were part of the Rural Development Programme for England. Herefordshire Council submitted an addendum to government and is awaiting decision.

#### Ledbury Project ideas

- Proposals to improve employment opportunities in Ledbury by building high tech business units on part of the viaduct site that has been allocated to employment. Need to liaise with Bloor Homes, which has been granted outline planning consent by the Secretary of State on Appeal, in terms of access to utilities (gas, electric, water) for the employment site. Need to commission a technical work.
- Railway Station infrastructure improvement to prepare for the extra services between Worcester and Birmingham would be provided as part of the Midlands Rail Hub project. Need to commission a technical work.
- Trading Estate by the railway station. Need to commission a feasibility study.
- Employment land e.g. land owned by Heineken which is 6.7 acres of existing brownfield land. Need to employ a development company to identify technical solutions to employment land in Ledbury. There is also a need to set a private/public partnership to take this forward.
- Digital artwork for window displays in the high town.

- Funding for training for business e.g. marketing, and learning from previous projects e.g. circular walks, poetry project, transfer learning from BID.
- Town maps and visitor boards
- Brown signage to promote attractions in the market towns

#### Next steps:

- Town council to identify funding proposals, including those which requires feasibility studies, etc.
- Prepare funding applications in the new year. Vinia to support.

#### LOCAL SIGNAGE - CORRESPONDENCE RECEIVED FROM LEDBURY PLACES

#### **Purpose of Report**

The purpose of this report is to inform Members of the Planning, Economy & Tourism Committee of correspondence received from Ledbury Places about working together to improve signage around the town.

#### **Detailed Information**

The Clerk recently received an email from Al Braithwaite of Ledbury Places advising that at a recent meeting she had presented a report on their visitor numbers and feedback received. Al advises that one of the questions asked where visitors had heard about them and several responses had indicated that it had been due to local signage, which Ledbury Places took to be the A Board outside the Old Grammar School.

This prompted a discussion about the benefits of having a finger post style sign at the bottom of Church Lane, and Al has written to ask whether the Town Council and Ledbury Places might work together on getting a sign placed at the bottom of Church Lane.

Members will recall that at the last meeting of the Committee it was agreed that officers should investigate the possibility of more signage around the town to indicate the various shopping areas etc. As a council it is not always easy to obtain grant funding for projects like this, as you will often be advised that you should raise funds for such projects via your precept. Working with an organisation like Ledbury Places may open up funding streams, as they could be applied for in the Ledbury Places name with support from the Town Council.

To date due to workload and the Christmas period officers have not yet had the opportunity to discuss signage with the appropriate officers at Herefordshire Council or BBLP.

#### Recommendation

That Members of the Planning, Economy & Tourism Committee authorise the Clerk to work with Ledbury Places and meet with the relevant officers from either Hereford Council or BBLP to discuss the possibility of having new signage located around the town and that they also investigate possible funding streams for this type of project.

# LAND BETWEEN LEADON WAY AND AMCOR – LEDBURY 2022 (NO.664) Tree Preservation Order

The County of Herefordshire District Council in exercise of the powers conferred on them by section 198 of the Town and Country Planning Act 1990 make the following Order—

#### Citation

This Order may be cited as Land between Leadon Way and Amcor - Ledbury (2022) (NO.664) Tree Preservation Order

#### Interpretation

1.— (1) In this Order "the authority" means the County of Herefordshire District Council

(2) In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation)(England) Regulations 2012.

#### **Effect**

- 2.— (1) Subject to article 4, this Order takes effect provisionally on the date on which it is made.
- (2) Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—
  - (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
  - (b) cause or permit the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of.

any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

#### Application to trees to be planted pursuant to a condition

**3.** In relation to any tree identified in the first column of the Schedule by the letter "C", being a tree to be planted pursuant to a condition imposed under paragraph (a) of section 197 (planning permission to include appropriate provision for preservation and planting of trees), this Order takes effect as from the time when the tree is planted.




