RESOLVED:

TMWP 16. DECLARATIONS OF INTEREST

None received.

TMWP 17. TO APPROVE AND SIGN AS A CORRECT RECORD THE MINUTES OF THE MEETING OF THE TRAFFIC MANAGEMENT WORKING PARTY HELD ON 25 OCTOBER 2023

It was noted that Steve Glennie-Smith had been recorded as a Councillor rather than a non-council, which it was noted will be corrected in future minutes.

RESOLVED:

That the minutes of the meeting of the Traffic Management Working Party held on 25 October 2023 be approved and signed as a correct record, subject to the above amendment.

TMWP 18. POSSIBLE INTRODUCTION OF HOPPER TYPE BUS IN LEDBURY

The Clerk provided an update on the meeting she had had with Clare Stone of Buses 4us.

The Clerk advised that Clare had informed that there are a number of grants available for the purchase of electric buses which the Town Council should investigate.

RESOLVED:

TMWP 19. UPDATE ON PROGRESS IN RESPECT OF SPEED INDICATOR DEVISES (SID's)

Members were provided with an update on the progress with SID's. The Clerk advised that this was due to be approved at the meeting that evening, following which she would need to establish "what three words" locations for where to request permission, via the Commissioning application, to place the SID's.

The Clerk also advised that she had discussed this with the Locality Steward, who had confirmed that he had no objection to the sites being proposed and would support the application when submitted.

RESOLVED:

- 1. That the SID's should be located at the following sites:
 - Hereford Road (A438) just after the 30-mile speed limit sign and before the entrance to Saxon Way into the town centre
 - Gloucester Way (A449) before Biddulph Way from the direction of the roundabout
 - Parkway (A417) at the top of the dip in the road as you enter Parkway going towards Ledbury
- 2. That Councillor Furlonger be asked to accompany the Clerk to establish "what three words" locations for each of the above sites.

TMWP 20. UPDATE ON S106 EXPENDITURE IN RESPECT OF ROAD SIGNAGE IN LEDBURY

Members were provided with an update in respect on the S106 Ledbury Weight Limit Signage review, which advised that AECOM had been commissioned to undertake this project, and that the report is in the final stages of being prepared, a copy of which will be provided to the Town Council on completion.
